

AATMANIRBHAR GUJARAT SCHEMES 2022

(Operative Period : 05.10.2022 to 04.10.2027)

CAPITAL SUBSIDY

Assistance of Capital Investment Subsidy to Micro Enterprise
(Small & Medium Enterprise are not eligible)

- **Category I** : @ 25% of Term Loan Amount upto Rs.35 lakhs
- **Category II** : @ 20% of Term Loan Amount upto Rs. 30 lakhs
- **Category III** : @ 10% of Term Loan Amount upto Rs. 10 lakhs

INTEREST SUBSIDY

Interest Subsidy to Micro, Small and Medium Enterprise for Manufacturing and Service Sector (for Service sector land & Building are not eligible)

- **Category I** : @ 7% of Term Loan with the maximum amount of Rs. 35 lakhs per annum for a period of 7 years
- **Category II** : @ 6% of Term Loan with the maximum amount of Rs. 30 lakhs per annum for a period of 6 years
- **Category III** : @ 5% of Term Loan with the maximum amount of Rs. 25 lakhs per annum for a period of 5 years
- **Differently able entrepreneur**:- 1% Additional interest subsidy
- **Women entrepreneur**:- 1% Additional interest subsidy
- **Registered Startup in Manufacturing** :- 1% Additional interest subsidy
- **Young Entrepreneur**:-1% Additional interest subsidy (Below 35 on the date of sanction of term loan)
- An existing enterprise which installs solar power plant or any other renewable power plant for captive consumption in the premises is eligible for interest subsidy in accordance with location of enterprise. (Comment: However, eligible enterprise shall have to bear minimum 2% interest levied on term loan by bank/financial institution.)
- The service listed at Annexure A (ii) shall have to comply with conditions:- Permanent employment to minimum 10 person & Must have GST registration

OTHER SUBSIDY

Electricity Duty Waiver

- Besides this, new industries will continue to get exemption from Electricity Duty for 5 years on power bill.

SGST Subsidy

 EFCI (Eligible Fixed Capital Investment) Rs. 10 Cr subsidy for Manufacturing Sector for 10 year (invest in project other than land)

- **Category I** : 100% of Net SGST for 10 Years upto 7.5% of EFCI per year
 - **Category II** : 90% of Net SGST for 10 Years upto 6.5% of eFCI per year
 - **Category III** : 80% of Net SGST for 10 Years upto 5% of eFCI per year
- (The period of 10 years shall be from the date of commencement of commercial production.)

EPF Reimbursement

- 100% of employer contribution under EPF
- Ceiling of incentive will be 12% of the basic salary + DA & retaining allowance of Rs.1800 per month which ever is lower
- MSME shall be able to claim reimbursement of employer's contribution under Employee's provident fund (EPF) for new employees working in Gujarat for a period of 10 years from Date of commercial Production.

Assistance for quality certification

- ERP Assistance – 65% of cost for ERP System upto Rs. 1,00,000/-
- Quality Certification – 50% of Fees payable for national/international certification and 50% cost of testing equipment's & machinery required for certification up to Rs. 10,00,000/-

Financial support to MSMEs in ZED (Zero defect & Zero effect) Certification

- ZED Certification - 50% of assistance upto Rs.50, 000.

Assistance in implementation of information and communication technology

- Incentive - 65% of assistance up to Rs.5, 00, 000.

Assistance for Technology Acquisition

- Incentive - 65% of assistance up to Rs.50, 00, 000.

Assistance for Patent Registration

- Incentive - 75% of assistance up to Rs.25, 00, 000.

Assistance for Saving in consumption of energy & water

Assistance for Raising Capital through SME Exchange

- 5% of expenditure incurred Maximum to Rs. 5, 00,000.

Assistance for Reimbursement of CGTSME Fees

- 100% Reimbursement of annual fees paid for five year.

Rehabilitation of Sick Enterprise

Assistance for Power connection charges

- 35% of charges paid to HT/LT service line up to Rs. 5, 00,000.

Assistance for rent to MSEs

- 65% of rent paid maximum limit of Rs. 1,00,000 per annum.
